



## ABSTRACT

Public Services – Tamil Nadu General Subordinate Service - Temporary post of Record Clerk in the Director of Environment – Ad-hoc Rules – Issued.

### ORDER:-

In the Government Order first read above, a new Department, namely Department of Environment has been sanctioned as a Nodal Department for dealing with Environmental Management of the State. In the Government Order second read above, a post of Record Clerk among other posts was sanctioned temporarily for the Department. The Director of Environment has proposed to constitute the post of Record Clerk under class XXII of the Tamil Nadu General Subordinate Service by issue of Ad-hoc rules and accordingly submitted necessary draft ad-hoc rules for approval of the Government. The Government after careful consideration have decided to approve the above draft Ad-hoc rules submitted by the Director of Environment, Chennai.

2. The following notification will be published in the Tamil Nadu Government Gazette:-

### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 7<sup>th</sup> May, 1997.

### RULES.

The General and Special Rules applicable to the holders of the permanent posts of Record Clerk in the category 1 A, of class XXII of the Tamil Nadu General Subordinate Service shall apply to the holder of the temporary post of Record Clerk in the Department of Environment, subject to the modifications specified in the following rules:-

2. **Constitution.**— The post shall constitute a separate category in the said class of the said service.

3. **Appointing authority.**— The Director, Department of Environment shall be the appointing authority for the post.
