<u>Project cost</u> (in Rs.)	<u>Scrutiny fee</u>
Below 5 crores	Rs. 50,000
Above 5 crores-below 50 crores	Rs. 2 lakhs
Above 50 Crores-below 100 crores	Rs. 5 lakhs
Above 100 crores-below 500 crores	Rs. 10 lakhs
Above 500 crores	Rs. 20 lakhs

The above fee structure is applicable to all projects of Government and its Undertakings also. This order will take effect with effect from 20.7.99.
