### **ORDER:**

In the Government Orders first read above, a new Department, namely Department of Environment has been created as a Nodal Department for dealing with environment management of the State. In the Government Order second read above, formation of a Green Squad for Coastal Conservation for checking Coastal Regulations Zone violations was sanctioned. In the Government orders third read above, a post of Assistant Conservator of Forests among other posts was sanctioned temporarily for the Department of Environment. The Director of Environment has proposed to constitute the post of Assistant Conservator of Forests under the Tamil Nadu Forest Service by issue of Adhoc rules and accordingly submitted draft ad-hoc rules for the approval of the Government. The Government after careful consideration have decided to approve the draft ad-hoc rules submitted by the Director of Environment, Chennai.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

### **NOTIFICATION.**

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-



2. The rules hereby made shall be deemed to have come into force on the 29<sup>th</sup> March 2005.

**RULES.**

The General and Special Rules applicable to the holders of the permanent post of Assistant Conservator of Forests Category-2 of the Tamil Nadu Forest Service shall apply to the holders of the temporary post of Assistant Conservator of Forests, in the Department of Environment, subject to the modifications specified in the following rules:-

2. **Constitution.**- The post shall constitute a distinct category in the said service.

3. **Appointment.**- By Transfer from category 2 of the Tamil Nadu Forest Service.

4. **Pay.**- There shall be paid to the holder of the post a monthly pay calculated in the scale of pay of Rs.8000-275-13500:

Provided that on and from 1<sup>st</sup> January 2006 the monthly pay shall be calculated in the scale of Rs. 15600-39100 + Rs. 5400 as Grade Pay (PB.3).
