Rules-Tamil Nadu General Service – Temporary post of Deputy Director (Impact Assessment Division) in the Directorate of Environment – Ad hoc rules – Orders Issued.

ORDER:-

In the G.O. first read above, a temporary Directorate, namely Directorate of Environment has been sanctioned as a Nodal Department for dealing with Environment Management of the State. In the G.O. second read above, a temporary post of Deputy Director (Impact Assessment) in the pre revised scale of pay of Rs.3000-100-3500-125-4500, among others, was sanctioned for the Directorate. The above post was filled up on 13.9.2000 FN. As the Department, as well as the posts, created for the Department are all temporary, it has been proposed to classify the post of Deputy Director (Impact Assessment) under Tamil Nadu General Service by means of Adhoc Rules. The Director Department of Environment has sent draft adhoc rules for the post of Deputy Director (Impact Assessment). The Government have examined it and proposed to accept it.

2. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

- * 2. The rules hereby made shall be deemed to have come into force on the 13th September 2000.

RULES.

The General and Special Rules applicable to the holders of the permanent posts in Class V of the Tamil Nadu General Services shall apply to the holder of the temporary post of Deputy Director (Impact Assessment) of Directorate of Environment, subject to the modifications specified in the following rules:-

2. Constitution.– The post shall constitute a separate category in the said service.

3. **Appointment.**- Appointment to the post shall be made by transfer from among the holder of the post of Deputy Director in the Tamil Nadu General Service or by recruitment by transfer from the Engineering Service:

4. **Qualification.**- No person shall be eligible for appointment to the post unless he possess the following qualification, namely:-

- (1) Must have passed a Bachelor Degree in Civil Engineering or Environmental Engineering or Chemical Engineering or a Post Graduate degree in Zoology or Botany or Agriculture or Forestry or Geology or Chemistry;
- (2) Must have worked in a post carrying the same scale of pay for a period of not less than three years.

5. **Probation.**- Every person appointed to the post shall, from the date on which he joins duty, be on probation for a total period of one year on duty within a continuance period of two years.

6. **Pay.**- There shall be paid to the holder of the post a monthly pay calculated in the scale of Rs.3000-100-3500-125-4000.

Provided that on and from the 1st January 1996 the monthly pay shall be calculated in the scale of Rs.10000-325-15200 and from the 1st January, 2006 the monthly pay shall be calculated in the scale of Rs. 15600-39100 + 6600/- Grade pay.
