ORDER:-

In the Government Order first read above, a new Department, namely Department of Environment has been sanctioned as a Nodal Department for dealing with Environmental Management of the State. In the Government Orders first to third read above, among other posts, the posts of Office Assistant were sanctioned temporarily for the Department. The Director of Environment has proposed to constitute the temporary post of Office Assistants under the Tamil Nadu Basic Service by issue of Ad-hoc rules and accordingly submitted necessary draft ad-hoc rules for the approval of the Government. The Government after careful consideration have decided to approve the draft ad-hoc rules submitted by the Director of Environment, Chennai.

2. The following Notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The Rules hereby made shall be deemed to have come into force on the 13th October 1995.

RULES.

The General and Special Rules applicable to the holders of permanent posts in category 5 of Class III of the Tamil Nadu Basic Service shall apply to the holders of the temporary post of Office Assistants in the Department of Environment, subject to the modifications specified in the following rules:-

2. **Constitution.**- The post shall constitute a separate unit in the said category in the said class of the said service.

3. **Appointing Authority.**- The appointing authority for the post shall be the Director, Department of Environment.

4. **Pay.**- There shall be paid to the holder of the post a monthly pay calculated in scale of Rs.750-12-870-15-940:

Provided that on and from 1st January 1996 the scale of pay is Rs. 2550-55-2660-3200:

Provided further that on and from the 1st January 2006 the scale of pay is Rs. 4800 – 10000 + Rs.1300 as Grade Pay (Pay Band1A)
