ORDER:-

In the Government Order first read above, a new Department, namely Department of Environment has been sanctioned as a Nodal Department for dealing with Environmental Management of the State. In the Government Order second read above among others a temporary post of Accounts Officer has been sanctioned for the Department of Environment. The Director of Environment has proposed to constitute the post of Accounts Officer under the Tamil Nadu State Treasury & Accounts Service by issue of Ad-hoc rules and accordingly submitted necessary draft ad-hoc rules for acceptance of the Government. The Government after careful consideration have decided to accept the draft ad-hoc rules sent by the Director of Environment.

2. The following notification will be published in the Tamil Nadu Government Gazette:-

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following rules:-

2. The rules hereby made shall be deemed to have come into force on the 3rd July 1997.

RULES.

The General and the Special Rules applicable to the holders of the permanent post of Accounts Officer in category -1 of Class -- III in the Tamil Nadu State Treasury and Accounts Service shall apply to the holders of the temporary post of Accounts Officer in the Department of Environment, subject to the modifications specified in the following rules:-

2. Constitution.— The post shall constitute a temporary addition to the said category in the said class of the said service.

3. Method of Appointment – Appointment to the post shall be made by transfer from the post of Accounts Officer in category – 1 of Class-III of the said Service.

3. Pay.— There shall be paid to the holder of the post a monthly pay calculated in the pre revised scale of pay of Rs.8000-275-13500.

Provided that on and from 1.1.2006 the monthly pay shall be calculated in the scale of Rs. 15600-39100 + Rs. 5400 as Grade Pay (P.B.3).

Provided that the monthly pay shall be calculated in the scale of Rs. 15600-39100 + Rs. 5700 as Grade Pay (P.B.3) notionally with effect from 12.12.2007 and with monetary benefit from 1.8.2010.
