ORDER:-

In the Government order first read above, the Government have constituted three Coastal Management Authorities under section 4 of Coastal Regulation Zone Notification, dated 19.02.1991 for monitoring and enforcement of the Coastal Regulation Zone in Tamil Nadu viz., State Level, District Level and Chennai Metropolitan Development Authority Areas. As per the Government Order first read above, the District Coastal Zone Management Authority for Chennai Metropolitan Development Authority areas under the Chairmanship of Senior Planning Officer, Chennai Metropolitan Development Authority along with one Vice Chairman, two Members and Convener. The role

and functions of District Coastal Zone Management Authority and Chennai Metropolitan Development Authority Areas are given below:-

- (i) To be responsible for monitoring and enforcement / Implementation of the provisions of Coastal Regulation Zone Notification.
- (ii) To ensure that the activities within Coastal Regulation Zone take place as per approved Management Plan
- (iii) To assist the State Authority in undertaking the sponsored investigation and research activities in relation to protection and conservation of Coastal Environment.
- (iv) To advice the State Government on any matter relating to protection and control of pollution in Coastal areas.
- (v) To act as an Authority under Sec.4 of Coastal Regulation Zone Notification, 1991, dated 19.02.1991 for taking action on Coastal Regulation Zone Plan Violations.
- (vi) To co-ordinate the activities of the Coastal Zone Management Committee of various Coastal areas and to provide guidance.
- 2. In the Government order second read above, the Government have reconstituted the District Coastal Zone Management Authority for Chennai Metropolitan Development Authority areas under the Chairmanship of the Director of Environment, wherein the Member-Secretary, Chennai Metropolitan Development Authority has been nominated as Member in supersession of orders issued in para 4(III) of G.O.(Ms).No.163, E&F Dept., dated 09.06.1998.
- 3. In the Government order third read above, the Government have reconstituted the District Coastal Zone Management Authority for Chennai Metropolitan Development Authority Areas as follows:-
